## CONFIDENTIAL PROPERTIES: Information Limitations

Please be aware of the impacts of protecting your home address from the public record.

Florida's open government laws (Florida Statute 119.071) provide for public access to records unless specifically exempted by the Florida Legislature.

Effective October 1, 2021, a county property appraiser must comply by removing the name of the individual with exempt status, mailing address, and the Official Records book and page number identifying the property from all publicly available records maintained by the property appraiser's office.

However, a county property appraiser **may not** remove the street address, legal description, parcel identification number, or other information identifying real property within the agency's records.

### **Property owners who apply and qualify for confidential status at our office will NOT be able to:**

- Online file for homestead exemption
- Utilize the online Tax Estimator function
- Receive property information over the telephone
- Receive unredacted records through the mail without notarized release
- Request us to provide property related data without a notarized release to:
  - *Contractors*
  - *Mortgage Companies*
  - *Realtors*
  - *Appraisers*
  - *All Others*

In order to release any exempted information related to a confidential address, the protected owner must come to our office in person, produce personal identification, and sign a release OR submit a notarized written release which specifies the information to be released, and the party who is authorized to receive the information.

*Please note that Florida Statute also allows for the release of this information to title companies and Florida attorneys without approval from the property owner. The individual is required to attest to needing the information for a valid, specified reason.*

To apply for confidential status, submit a CONFIDENTIALITY APPLICATION to our office with supporting documentation.

**NOTE: A NEW APPLICATION MUST BE FILED WHEN PROPERTY IS SOLD OR NEW PROPERTY PURCHASED. ADDRESS BLOCKING IS ONLY FOR DOCUMENTS IN SEMINOLE COUNTY PROPERTY APPRAISER PUBLIC RECORDS. TO BLOCK INFO ON THE CLERK OF THE COURT SITE, CONTACT THEM AT 407.665.4336.**
