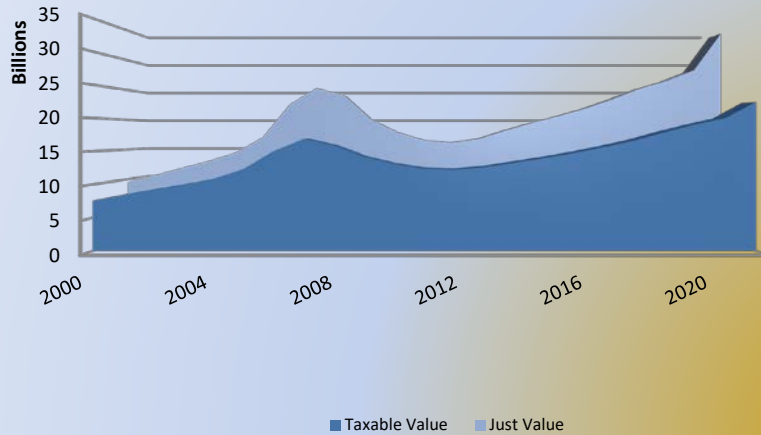

St Johns River Water Mgmt District Just & Taxable Value History 2000 - 2022



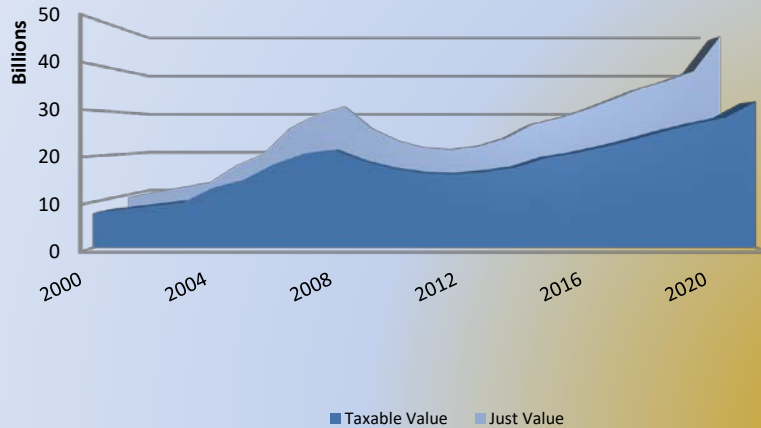

Seminole County Unincorporated Just & Taxable Value History 2000 - 2022



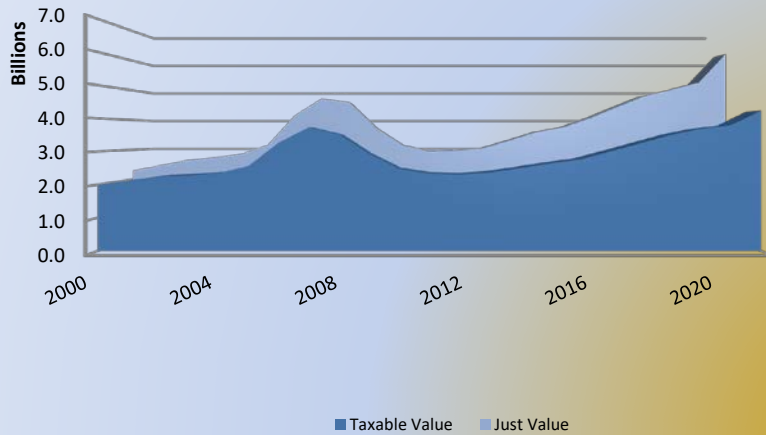
